#### TOWNSHIP RESIDENTS

• Fred and Dolores Wesley, Factory Road: The Dolores' noted a problem at the corner of Factory Road and Lehman Drive. The Stop signs stop traffic in two directions but not the third and a line of sight issue is causing near accidents due to oncoming traffic not having to stop. After discussion, Chairman Hamm instructed Scott Paulhamus to order and install a new sign that reads Oncoming Traffic Does Not Stop.

#### POLICE REPORT

• January 2018 – 32 incidents; YTD – 32 incidents.

### FIRE COMPANY – Chief Jeff Tempesco

- January 2018 55 incidents; Hepburn Twp 22 incidents in January 2018
- Chief Tempesco reported that HTVFC were awarded 2 state grants totaling \$20,238. The fire department will receive \$13,201 for Fire and the EMS portion is \$7,037.
- Chief Tempesco reported the fire company is still working on a possible carnival and dates for this summer.

## **ROAD FOREMAN REPORT** – Scott Paulhamus

- Mr. Paulhamus stated that the road crew is keeping up with the snow.
- Mr. Paulhamus informed the Board that Lorson Logging Company wants to log 17 acres of township property near Powys. Chairman Hamm stated that the Board would like to see a proposal for the work.

- Don Free from PennDot went over the township roads with Scott and has made recommendations for paving.
- Mr. Paulhamus stated fuel and stone bids will be posted in the coming month.

#### **ZONING/CODES OFFICER** – Don Robinson

#### **OLD BUSINESS**

• Mutchler Park Playground – A donation and grant money total \$15,000 for playground equipment at Mutchler Park. Kenneth Snyder pledged \$10,000 toward the playground equipment and would confirm with the Township in the coming months. Chairman Hamm stated there is a DCNR grant and that the Township will apply for it to help pay for the upgrades. Chairman Hamm stated the Township is still looking to raise the funds needed to complete the upgrade.

#### **NEW BUSINESS**

- PennDot issued a notice that no signs are to be placed in the state right-of-way. PennDot has requested that the Bloomingrove Historical Society sign be updated to fulfill the new requirements. They will be working with PennDOT's TODS Program (Tourist Oriented Directional Signage) to comply.
- Seneca Resources; Gamble Pad P The drilling rig is now scheduled to be in place on April 4 to begin drilling operations.
